FUND OBJECTIVE Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.

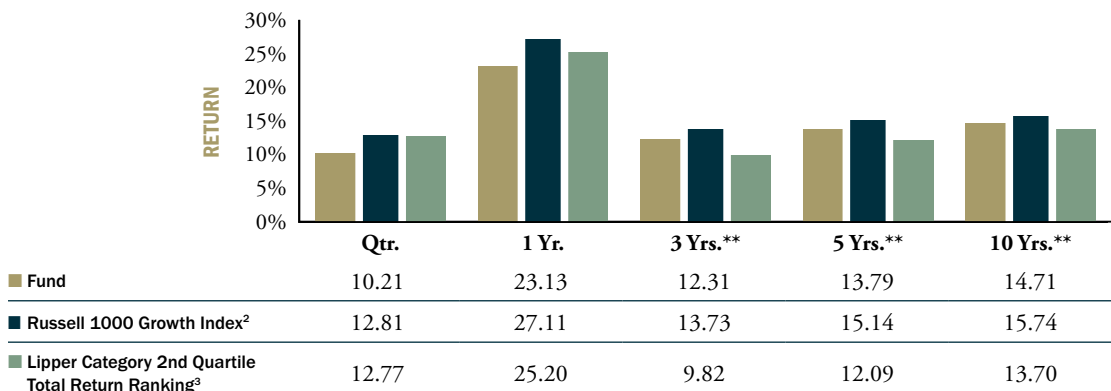
GROWTH FUND UPDATE

In the second quarter, equity markets continued the rally that started in the fourth quarter of 2022. The Federal Reserve (Fed) had two meetings this quarter, which resulted in another quarter point hike followed by the first pause seen since the rate hikes began in March of 2022. The Fed's commentary remained cautious on the inflation outlook, but with stronger economic reports, equity markets posted a solid second quarter with growth stocks leading the way. The Commerce Growth Fund's return of 10.21% underperformed the Russell 1000 Growth Index return of 12.81%.

Stock selection was a detractor to the Fund's performance. The Fund's strongest stocks were Palo Alto Networks, Inc. (0.95%), and Copart, Inc. (0.94%), returning 27.92% and 21.27%, respectively. The Fund's top detractors were Estee Lauder Companies Inc. (0.92%), and MSCI Inc. (0.92%), returning -20.05%, and -15.91%, respectively.

The Fund's sector allocation was a slight detractor to performance. The Fund's 0.92% overweight in the Consumer Discretionary sector, which returned 15.85%, added to performance. The Index has a 14.22% weight in the Consumer Staples sector. However, the Fund's 4.18% underweight in the Information Technology sector, which returned 19.34%, detracted from performance as it was the best performing sector. The Index had a 42.48% weight in the Information Technology Sector.

*** Lipper Analytical Services, Inc. is an independent publisher of mutual fund rankings, records rankings for these and other Commerce Funds for one-year, three-year, five-year, and ten-year total returns periods. Lipper compares mutual funds within a universe of funds with similar investment objectives, including dividend reinvestment. Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns. Exchange-traded funds and open-ended mutual funds are considered a single population. In each category, the top 10% = 5 stars, next 22.5% = 4 stars, next 35% = 3 stars, next 22.5% = 2 stars, and bottom 10% = 1 star.
