Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.


GROWTH FUND UPDATE

Despite concerns of rising inflation, the equity market continued its rally while the Russell 1000 Growth Index soared to new highs. This was fueled by an accelerated pace of vaccinations, decelerated rates of COVID-19 cases, and continued support from the Federal Reserve to remain accommodative. For the second quarter, The Commerce Growth Fund's return of 9.97% underperformed the Russell 1000 Growth Index of 11.93%.

Stock selection had the largest negative impact on the Fund's performance relative to the Index. The Fund's top detractors were Citrix Systems, Inc. (0.00%), and Fiserv, Inc. (1.03%), returning -17.23%, and -10.21%, respectively. The Fund's strongest stocks were Alphabet Inc. Class A (5.05%) and Public Storage (1.04%) returning 18.39% and 22.68%, respectively.

The Fund's sector allocation had a slight negative impact on the Fund's performance. The fund was overweight 2.35% the Materials sector, which was the worst performing sector for the quarter returning 2.97%. The index had a 0.81% weight to the Materials sector. In addition, the Fund was 2.66% overweight the Industrials sector which only returned 8.25% for the quarter. The Index had a 4.74% weight to the Industrials sector. Helping performance, the Fund underweighted the Consumer Staples sector which returned 4.02% for the quarter. The Index had a 4.35% weight to the Consumer Staples sector while the Fund had a 2.27% weight to the sector.

2. The Russell 1000 Growth Index is an unmanaged index that measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values. 3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.

*** Lipper Analytical Services, Inc. is an independent publisher of mutual fund rankings, records rankings for these and other Commerce Funds for one-year, three-year, five-year, and ten-year total returns periods. Lipper compares mutual funds within a universe of funds with similar investment objectives, including dividend reinvestment. Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns. Exchange-traded funds and open-ended mutual funds are considered a single population. In each category, the top 10% = 5 stars, next 22.5% = 4 stars, next 35% = 3 stars, next 22.5% = 2 stars, and bottom 10% = 1 star.
