FUND OBJECTIVE Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.

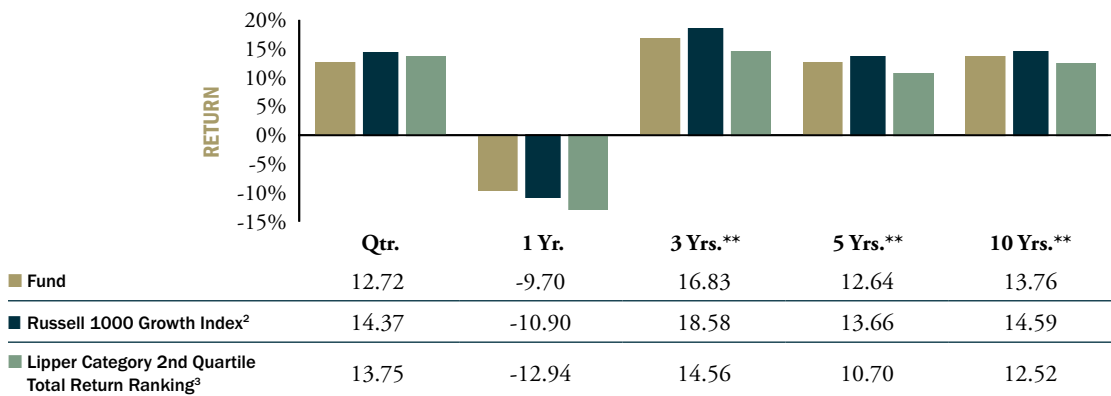
GROWTH FUND UPDATE

In the first quarter, growth stocks had a nice rally, after a dismal performance last year. The Information Technology, Communication Services and Consumer Discretionary sectors, which account for 57% of the Fund, provided the bulk of the returns for the Index. Growth stock performance was relatively unaffected by the several banking failures in mid-March. Investors are still very reactive to updated Federal Reserve commentary, job reports, and inflation prints, trying to determine the path of the economy for the rest of the year. The Commerce Growth Fund's return of 12.72% lagged the Russell 1000 Growth Index return of 14.37%.

Stock selection was a slight detractor to the Fund's performance. The Fund's strongest stocks were Palo Alto Networks, Inc. (1.17%), and Arista Networks, Inc. (1.25%), returning 43.13% and 38.33%, respectively. The Fund's top detractors were Dollar General Corporation (1.08%), Jack Henry & Associates, Inc. (0.86%), and Raymond James Financial, Inc. (0.82%) returning -14.53%, -13.88%, and -12.32% respectively.

The Fund's sector allocation was also a detractor to performance. The Fund's 0.97% underweight in the Consumer Staples sector, which returned 1.95%, added to performance. The Index has a 6.24% weight in the Consumer Staples sector. However, the Fund's 4.54% underweight in the Information Technology sector, which returned 24.86%, detracted from performance as it was the best performing sector. The Index had a 39.63% weight in the Information Technology Sector. Additionally, the Fund's 1.75% overweight to the Financial sector, which returned 4.01%, also took away from performance. The Index had a 7.30% weight in the Financial sector.

Lipper compares mutual funds within a universe of funds with similar investment objectives, including dividend reinvestment. Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
