FUND OBJECTIVE Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.

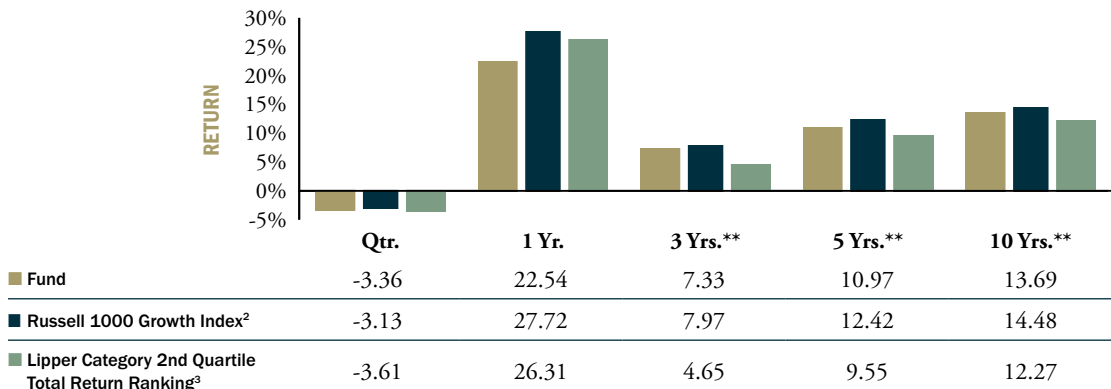
GROWTH FUND UPDATE

July started off strong, only to falter in August and September, producing negative returns for equities in the third quarter. The pickup in economic growth caught many investors off guard sending interest rates higher despite the Federal Reserve pausing and not hiking interest rates at both meetings during the quarter. With higher interest rates, investors feared the economy could fall into a recession in 2024, producing uncertainty for future earnings growth. The Commerce Growth Fund's return of -3.36% slightly lagged the Russell 1000 Growth Index return of -3.13%.

Stock selection added to the Fund's performance. The Fund's strongest stocks were Tradeweb Markets, Inc. (0.82%), CDW Corporation (0.84%), and MSCI Inc. Class A (0.98%), returning 17.24%, 10.27%, and 9.61%, respectively. The Fund's top detractors were Masimo Corporation (0.00%), Estee Lauder Companies Inc. (0.00%), and Mettler-Toledo International Inc. (0.84%), returning -39.31%, -22.88%, and -15.52%, respectively.

The Fund's sector allocation was a slight detractor to performance. The Fund's 2.45% underweight in the Information Technology sector, which returned -5.92%, added to performance. The Index has a 42.50% weight in the Information Technology sector. However, The Fund's 2.82% underweight in the Communication Services sector, which returned 5.18%, detracted from performance. The Index had a 11.28% weight in the Communication Services Sector.
