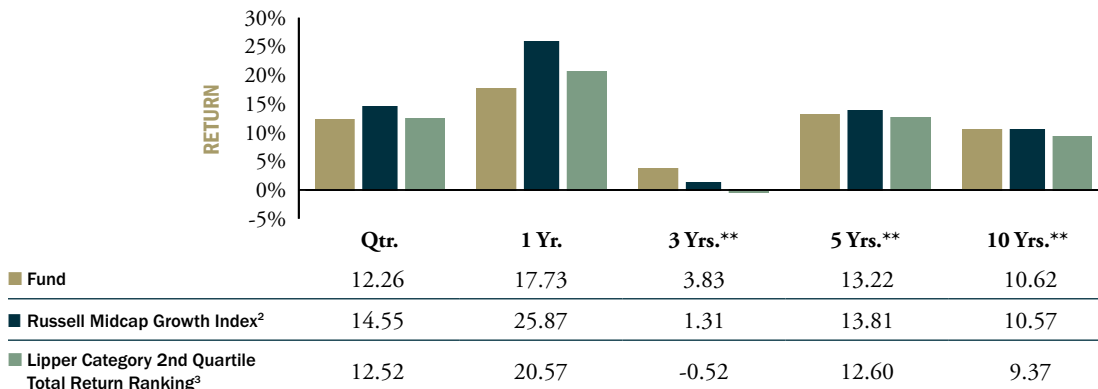
MIDCAP GROWTH FUND UPDATE

After a weak beginning to the quarter, equity prices found their footing in November supported with continued positive economic news. The rally was provided a further lift in December with unanticipated comments from the Federal Reserve regarding a potential pivot from increasing to decreasing short interest rates in 2024. As we closed the quarter, most equity indexes were posting 52-week highs. The Commerce MidCap Growth Fund's return of 12.26% trailed the Russell Mid Cap Growth Index return of 14.55%.

Stock selection detracted from the Fund's performance. The Fund's strongest stocks were Karuna Therapeutics, Inc. (0.00%), GoDaddy, Inc. Class A (1.19%), and Five Below, Inc. (1.22%), returning 87.98%, 42.53%, and 32.48%, respectively. The Fund's top detractors were Paycom Software, Inc. (0.00%), Texas Pacific Land Corporation (1.22%), and Arch Capital Group Ltd. (1.07%), returning -38.67%, -13.60%, and -6.82%, respectively.

The Fund's sector allocations performed in-line with the Index for the quarter. The Fund's 0.74% overweight to the Real Estate sector, returning 20.37%, added to performance as it was a stronger sector. The Index had a 1.68% weight in the Real Estate sector. The Fund's 0.67% overweight to the Consumer Staples sector, returning 5.93%, detracted from performance as it was a weaker sector. The Index had a 2.87% weight in the Consumer Staples sector.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
