
MIDCAP GROWTH FUND UPDATE

Equity markets saw a sharp drop in the second quarter as investors wrestled with underestimating the ongoing severity of inflation and increased fears of a recession. High oil, gas, food, and labor prices continued to drive inflation across most economic sectors. Sharply rising interest rates are putting downward pressure on price to earnings multiples causing lower valuations despite ongoing modest earnings growth. The Commerce MidCap Growth Fund's return of -16.07% outperformed the Russell Mid Cap Growth Index return of -21.07%.

Stock selection was a positive contributor to the Fund's performance. The Fund's strongest stocks were Lamb Weston Holdings, Inc. (1.23%), Continental Resources, Inc. (1.14%), and Booz Allen Hamilton Holding Company (1.27%), returning 19.74%, 7.03%, and 3.41%, respectively. The Fund's top detractor was Cognex Corporation (0.00%) which returned -40.98%.

The Fund's sector allocations positively contributed to performance for the quarter. The Fund's 2.07% overweight to the Consumer Staples Sector, the best performing sector, returning -3.51%, added to performance. The Index had a 2.28% weight to the Consumer Staples Sector. Also, the Fund's 1.75% underweight to the Communication Services sector, the worst performing sector, returning -30.48%, added to performance. The Index had a 2.92% weight in the Communication Services Sector. However, the Fund's 1.62% underweight to Energy, the second-best performing sector, returning -3.97%, detracted from performance. The Index had a 3.00% weight in the Energy sector.

Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
