
MIDCAP GROWTH FUND UPDATE

The third quarter was a tale of two halves, starting off with a relief rally that was dashed by continued strength in the labor market combined with the persistence of inflation causing the Federal Reserve to move forward with aggressive rate hikes. Between the rate hikes and continued stock sell-off, investor confidence dwindled. The Commerce MidCap Growth Fund's return of -1.67% underperformed the Russell Mid Cap Growth Index return of -0.65%.

Stock selection detracted the Fund's performance. The Fund's strongest stocks were Alnylam Pharmaceuticals, Inc (0.00%) and Cheniere Energy, Inc. (1.27%), returning 41.51% and 24.99%, respectively. The Fund's top detractors were Exelixis, Inc. (1.20%), Church & Dwight Co., Inc. (1.21%), and Domino's Pizza, Inc. (-1.18%), which returned -24.69%, -22.67, and -20.15%, respectively.

The Fund's sector allocations positively contributed to performance for the quarter. The Fund's 3.57% underweight to the Communication Services sector, returning -5.92%, added to performance. The Index had a 4.81% weight in the Communication Services sector. Also, the Fund's 2.25% underweight to the Health Care sector, returning -6.10%, added to performance. The Index had a 16.61% weight in the Health Care sector. However, the Fund's 1.71% underweight to Energy, the best performing sector, returning 5.42%, detracted from performance. The Index had a 4.43% weight in the Energy sector.

**** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
