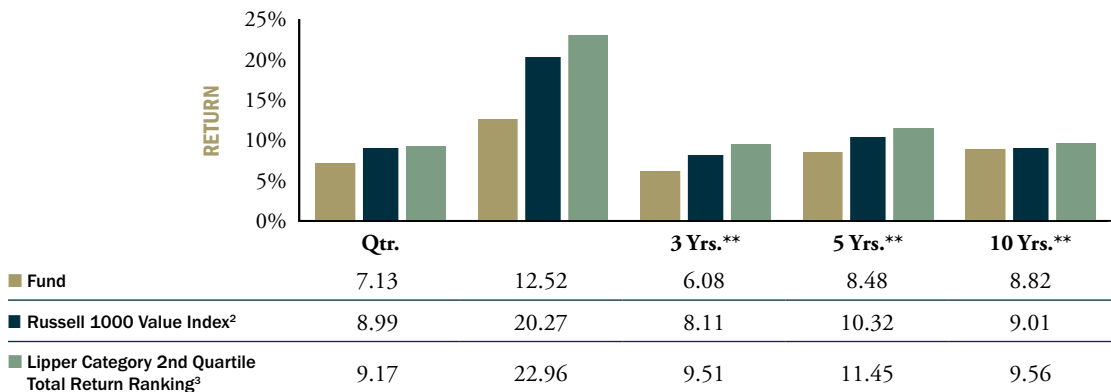
**VALUE FUND UPDATE**

Following a strong rebound in equity markets last year, the first quarter continued the advance, posting new all-time highs for the Russell 1000 Value Index. Current economic releases indicated moderate economic growth for 2024 and the prospects for a recession are pushed further into the future. The Commerce Value Fund's return of 7.13% trailed the Russell 1000 Value Index return of 8.99%.

Stock selection detracted from the Fund's performance. The Fund's strongest contributors were Valero Energy Corporation (1.19%), Eaton Corp. Plc (1.87%), and Apollo Global Management Inc (1.85%), returning 32.31%, 30.25%, and 21.13%, respectively. The Fund's top detractors were Air Products and Chemicals, Inc. (1.43%), United Parcel Service, Inc. Class B (1.79%), and Public Storage (1.25%), returning -10.87%, -4.43%, and -3.92%, respectively.

The Fund's sector allocation performed in line for the quarter. The Fund's 1.52% underweight in the Health Care sector, which returned 6.27%, added to performance as it was a weaker sector. The Index had an 14.73% weight in the Health Care sector. However, the Fund's 0.49% overweight position in the Real Estate sector hurt performance as it was the weakest sector, losing -0.93% for the quarter. The Index had an 4.80% weight in the Real Estate sector.

1. The Net Asset Value represents the assets of the Fund (ex dividend) divided by the total number of shares.
2. The Russell 1000 Value Index is an unmanaged market capitalization weighted index of the 1,000 largest U.S. companies with lower price-to-book ratios and lower forecasted growth values. The Index figures do not reflect any deduction for fees, expenses or taxes. It is not possible to invest directly in an unmanaged index.
3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.

The method of calculation of the 30-Day Standardized Subsidized Yield is mandated by the Securities Exchange Commission and is determined by dividing the net investment income per share earned during the last 30 days of the period by the maximum public offering price of the Fund ("POP") per share on the last day of the period. This number is then annualized. The 30-Day Standardized Subsidized Yield reflects fee waivers and/or expense reimbursements recorded by the Fund during the period. Without waivers and/or reimbursements, yields would be reduced. This yield does not necessarily reflect income actually earned and distributed by the Fund and, therefore, may not be correlated with the dividends or other distributions paid to shareholders. The 30-Day Standardized Unsubsidized Yield does not adjust for any fee waivers and/or expense reimbursements in effect.
