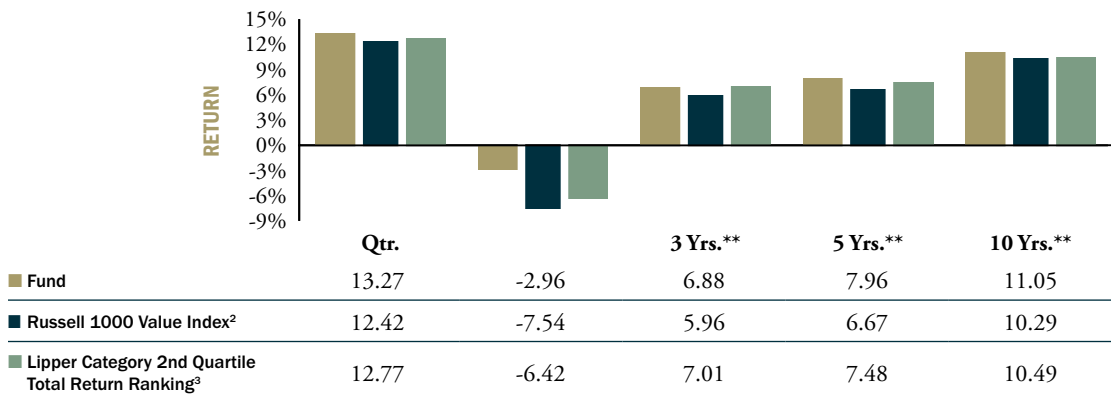
VALUE FUND UPDATE

In the fourth quarter, large cap value equities began with a very volatile 2-month rally, followed by 25% of it being given back in December. The general trends appeared to be that inflation is cooling, job growth is resilient, and how much higher do short term interest rates need to be raised to slow the economy? These three topics seemed to take priority over holiday consumer sales and a mixed congress election from mid-terms. The Commerce Value Fund's return of 13.27% outperformed the Russell 1000 Value Index return of 12.42%.

Stock selection added to the Fund's performance. The Fund's strongest stocks were Emerson Electric Co. (1.98%), Interpublic Group of Companies, Inc. (2.03%), and Merck & Co., Inc. (2.96%) returning 31.95%, 31.22%, and 29.67%, respectively. The Fund's top detractors were Dominion Energy Inc. (0.00%) and Public Storage (1.86%), which returned -15.15% and -3.68% respectively.

The Fund's sector allocations also added to performance for the quarter. The Fund's 1.62% underweight in the Communication Services sector, which returned 2.30%, added to performance as it was the worst performing sector. The Index had a 7.50% weight in the Communication Services sector. Also, the Fund's 1.57% overweight to the Energy sector, returning 22.80%, added to performance. The Index had an 8.59% weight in the Energy sector. However, the Fund's equal weight position in the Utilities sector hurt performance as it was a weaker sector, only gaining 8.63% for the quarter. The Index had a 5.67% weight in the Utilities sector.

1. The Net Asset Value represents the assets of the Fund (ex dividend) divided by the total number of shares.
2. The Russell 1000 Value Index is an unmanaged market capitalization weighted index of the 1,000 largest U.S. companies with lower price-to-book ratios and lower forecasted growth values. The Index figures do not reflect any deduction for fees, expenses or taxes. It is not possible to invest directly in an unmanaged index.
3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.
4. Fund holdings and allocations shown are unaudited, and may not be representative of current or future investments. The method of calculation of the 30-Day Standardized Subsidized Yield is mandated by the Securities Exchange Commission and is determined by dividing the net investment income per share earned during the last 30 days of the period by the maximum public offering price of the Fund ("POP") per share on the last day of the period. This number is then annualized. The 30-Day Standardized Subsidized Yield reflects fee waivers and/or expense reimbursements recorded by the Fund during the period. Without waivers and/or reimbursements, yields would be reduced. This yield does not necessarily reflect income actually earned and distributed by the Fund and, therefore, may not be correlated with the dividends or other distributions paid to shareholders. The 30-Day Standardized Unsubsidized Yield does not adjust for any fee waivers and/or expense reimbursements in effect. **** The Morningstar Rating™ is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
