
VALUE FUND UPDATE

Equity markets saw a sharp drop in the second quarter as investors wrestled with underestimating the ongoing severity of inflation and increased fears of a recession. High oil, gas, food, and labor prices continued to drive inflation across most economic sectors. Sharply rising interest rates are putting downward pressure on price to earnings multiples causing lower valuations despite ongoing modest earnings growth. The Commerce Value Fund's return of -9.94% outperformed the Russell 1000 Value Index return of -12.21%.

Stock selection was a positive contributor to the Fund's performance. The Fund's strongest stocks were Genuine Parts Company (1.97%), Merck & Co., Inc (2.61%), International Business Machine (2.04%), and W. P. Carey Inc. (2.01%), returning 6.23%, 12.02%, 9.92%, and 3.79%, respectively. The Fund's top detractors were Hanesbrands Inc. (0.00%) and T. Rowe Price Group (2.05%) which returned -30.48% and -24.02%, respectively.

The Fund's sector allocations detracted from performance for the quarter. The Fund's 2.94% underweight in the Health Care Sector, which returned -3.17%, detracted from performance as it was the best performing sector. The Index had a 18.63% weight to the Health Care Sector. Also, the Fund's 1.98% overweight to the Materials sector, returning -18.44%, detracted from performance. The Index had a 4.02% weight to the Materials sector. However, the Fund's 1.09% overweight in the Energy sector helped performance as it was among the best performing sectors, declining only 5.19% for the quarter. The Index had a 7.91% weight to the Energy Sector.

1. The Net Asset Value represents the assets of the Fund (ex dividend) divided by the total number of shares.
2. The Russell 1000 Value Index is an unmanaged market capitalization weighted index of the 1,000 largest U.S. companies with lower price-to-book ratios and lower forecasted growth values. The Index figures do not reflect any deduction for fees, expenses or taxes. It is not possible to invest directly in an unmanaged index.
3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.
4. Fund holdings and allocations shown are unaudited, and may not be representative of current or future investments. The method of calculation of the 30-Day Standardized Subsidized Yield is mandated by the Securities Exchange Commission and is determined by dividing the net investment income per share earned during the last 30 days of the period by the maximum public offering price of the Fund ("POP") per share on the last day of the period. This number is then annualized. The 30-Day Standardized Subsidized Yield reflects fee waivers and/or expense reimbursements recorded by the Fund during the period. Without waivers and/or reimbursements, yields would be reduced. This yield does not necessarily reflect income actually earned and distributed by the Fund and, therefore, may not be correlated with the dividends or other distributions paid to shareholders. The 30-Day Standardized Unsubsidized Yield does not adjust for any fee waivers and/or expense reimbursements in effect. Lipper compares mutual funds within a universe of funds with similar investment objectives, including dividend reinvestment. Lipper rankings are based on total return at net asset value and do not reflect sales charges. Lipper rankings do not imply that the fund had a high total return.

**** The Morningstar RatingTM is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns.
