Seeks capital appreciation and, secondarily, current income. The Fund pursues this objective through investment in equity investments of companies that are selling below fair market value compared to their future potential.

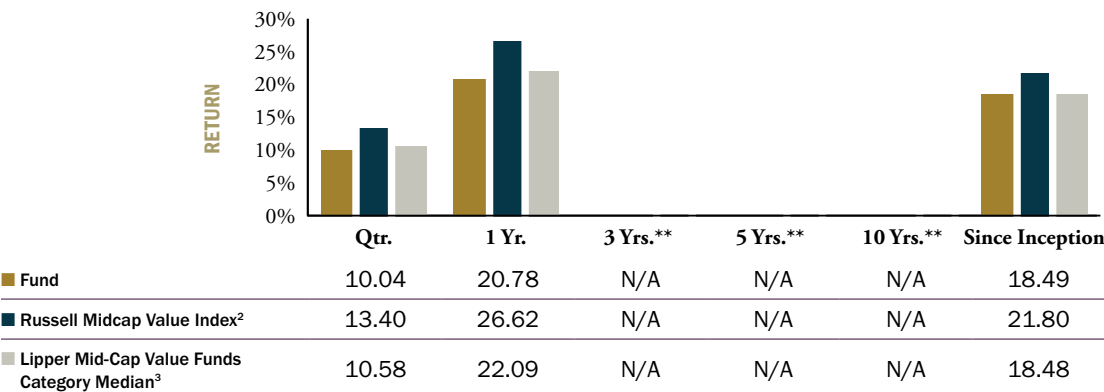
MIDCAP VALUE FUND UPDATE

Value equities posted solid gains during the second quarter as favorable economic conditions and resilient corporate earnings supported returns across several cyclical sectors. Investor enthusiasm for artificial intelligence and technology-related companies fueled a strong rally in certain areas of the market. These trends led Information Technology to have the strongest returns, posting a gain of 64.06% during the quarter. Financials and Industrials were among the stronger contributors within the value universe, benefiting from steady economic activity and improving business confidence, while Energy returns softened as oil prices retreated from earlier highs. The Commerce Mid Cap Value Fund's return of 10.04% underperformed the Russell Mid Cap Value Index's return of 13.40%.

Stock selection detracted from the Fund's performance. The Fund's strongest contributors were TD SYNnex Corporation (1.86%), Cognex Corporation (1.66%), and Timken Company (1.63%), returning 58.83%, 48.02%, and 44.97%, respectively. The Fund's top detractors were Cognizant Technology Solutions Corporation (0.71%), CME Group Inc. (0.82%), and Amdocs Limited (0.86%), returning -36.47%, -24.85%, and -21.68%, respectively. The Fund did not own two semiconductor stocks that had stellar performance during the period: Sandisk Corp. (+257.88%) and Western Digital Corp. (+136.20%). Together, not owning these two securities detracted 3.37% from the Fund's performance vs. the Russell Mid Cap Value Index.

The Fund's sector allocation was neutral towards performance for the quarter. The Fund's 0.78% underweight in the Energy sector added to performance as it was a weaker sector, returning -7.37%. The index had a 7.54% weight in the Energy sector. However, the Fund's 1.23% underweight position in the Information Technology sector detracted from performance as it was a stronger sector, returning 64.06%. The index had a 15.57% weight in the Information Technology sector.

1. The Net Asset Value represents the assets of the Fund (ex dividend) divided by the total number of shares.
2. The Russell Midcap Value Index is an unmanaged index that measures the performance of those Russell Midcap companies with lower price-to-book ratios and lower forecasted growth values. The Index figures do not reflect any deduction for Fees, expenses, or taxes. It is not possible to invest directly in an unmanaged index.
3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.

This number is then annualized. The 30-Day Standardized Subsidized Yield reflects fee waivers and/or expense reimbursements recorded by the Fund during the period. Without waivers and/or reimbursements, yields would be reduced. This yield does not necessarily reflect income actually earned and distributed by the Fund and, therefore, may not be correlated with the dividends or other distributions paid to shareholders.
