Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.


#### **GROWTH FUND UPDATE**

Growth stocks surged in Q2 2025, rebounding from the tariff shock at the beginning of April to end the quarter at record highs. Tech and Al-focused sectors drove the growth rally as easing trade tensions, including a temporary pause with China, helped restore investor confidence. While volatility related to tariffs persisted through the quarter, investors leaned back into resilient earnings, innovation, and dampened geopolitical risk amidst a better-than-expected macroeconomic backdrop. The Commerce Growth Fund's return of 13.70% underperformed the Russell 1000 Growth Index return of 17.84%.

Stock selection detracted from the Fund's performance. The Fund's strongest stocks were Amphenol Corporation Class A (0.99%), Spotify Technology SA (1.02%), and Bentley Systems, Incorporated Class B (0.92%), returning 50.82%, 39.51%, and 37.39%, respectively. The Fund's top detractors were UnitedHealth Group Incorporated (0.00%), Fiserv, Inc. (0.95%), and Copart, Inc. (0.90%), returning -40.01%, -21.93%, and -13.29%, respectively.

The Fund's sector allocation was negative for the Fund's performance. The Fund's 0.69% underweight in the Consumer Staples sector, which returned -0.03%, added to performance as it was the weaker sector. The Index had a 3.66% weight in the Consumer Staples sector. However, The Fund's 1.39% overweight in the Energy sector, which returned -9.75%, detracted from performance as it was the weakest sector. The Index had a 0.45% weight in the Energy sector.
